The following public questions will appear on the ballot for all Elkhart Township Precincts

For the eight (8) calendar years immediately following the holding of the referendum, shall Goshen Community Schools impose a property tax rate that does not exceed twenty-six cents (\$0.2600) on each one hundred collars (\$100) of assessed valuation and that is in additional to all other property taxes imposed by the School Corporation for the purpose of funding academic and educationally related programs, managing class sizes and retaining teachers?

Shall Goshen Community Schools issue bonds or enter into a lease to finance 2018 Safety, Security, Efficiency, Construction and Restoration Project which includes the renovation of and improvements to Goshen High School and Goshen Middle School, the construction of a new facility for intermediate level grade students, and safety, security and efficiency improvements at the other school facilities, which is estimated to cost not more than \$65,000,000 and is estimated to increase the property tax rate for deb service by a maximum of \$0.3790 per \$100 of assessed valuation?
